You would think the gun-grabbers would get the message after getting their first anti-gun "mental health" scheme killed earlier this session, but instead of respecting their constituents' wishes, they are doubling down and pushing full steam ahead.

Embedded in this bill are policy implications that could have a more far-reaching and devastating effect on our rights than anything that was passed in 2013.

This anti-gun ploy radically rewrites the definition of who may be deemed as mentally unfit to possess a firearm to defend themselves and their families.

And, once you are deemed mentally incompetent, they will throw you into the government's Brady Registration System, leaving you to languish without your rights and forcing your private medical records into the hands of government bureaucrats.

Now, the gun-grabbers want to dramatically expand the definition of who is "gravely disabled," and in the process, cast a net so wide, it's hard telling how many gun owners will be caught up in this scheme.

If HB 1386 were to become law, a person who has a temporary mood disorder, or has bee admitted twice (even voluntarily) for treatment in the last three years, could be an inch awa from losing their rights.

Even more dangerously, someone who the state has decided "lacks judgment" in the conduct of their "social relations" (yes, you read that right)could be deemed unfit to posses a firearm.

Also, this bill lowers the bar for how a person can be defined as a threat to themselves or others by changing the law from "imminent danger" to simply just "danger."

By removing that one word from the statutes, it makes the law so vague that even the slightest potential threat could make someone a "danger" to society, and result in the loss their rights, regardless of how serious the threat actually is.

Despite all of the aforementioned, HB 1386 will further stigmatize those with mental illness and dissuade those who actually do need help from seeking it.

Make no mistake, this is the last salvo the gun-grabbers will fire before the end of the legislative session, and gun owners must hold their feet to the fire and make them pay for every inch of ground they attempt to take.

We are so close to the end of the session, it would be a shame if we just let the gun-grabbers notch another victory in their belt.
